YOU WERE ISSUED A UNIFORM TRAFFIC CITATION FOR A VIOLATION OF SECTION 316.1001, FLORIDA STATUTES, WHICH REQUIRES THAT YOU COMPLY WITH ONE OF THE OPTIONS. IF YOU FAIL TO COMPLY WITH ONE OF THE FOLLOWING OPTIONS WITHIN THE PERIOD SPECIFIED BELOW, YOUR DRIVING PRIVILEGE WILL BE SUSPENDED AS OF THE DATE OF SUCH FAILURE UNTIL YOU COMPLY, YOU WILL NOT BE ABLE TO RENEW YOUR VEHICLE REGISTRATION, AND YOU SHALL BE REQUIRED TO PAY A PENALTY AND SERVICE FEE.

If you request a hearing and the County Judge/Traffic Hearing Officer determines that you have committed the offense, the County Judge/Traffic Hearing Officer may impose a penalty no to exceed \$500.00 AND POINTS WILL BE ASSESSED AS APPLICABLE. If the County Judge/Traffic Hearing Officer determined that no infraction has been committed, no cost or penalties shall be imposed. THE COURT WILL SCHEDULE YOUR HEARING DATE AND NOTIFY YOU.
